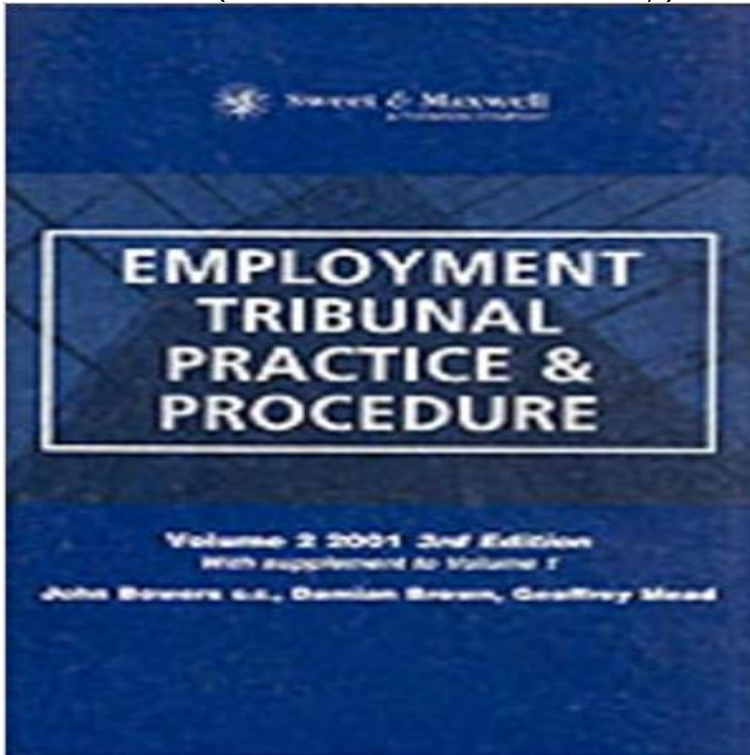


Employment Tribunal Practice and Procedure: 2001 Supplement to Volume 2 (Common Law Library)
