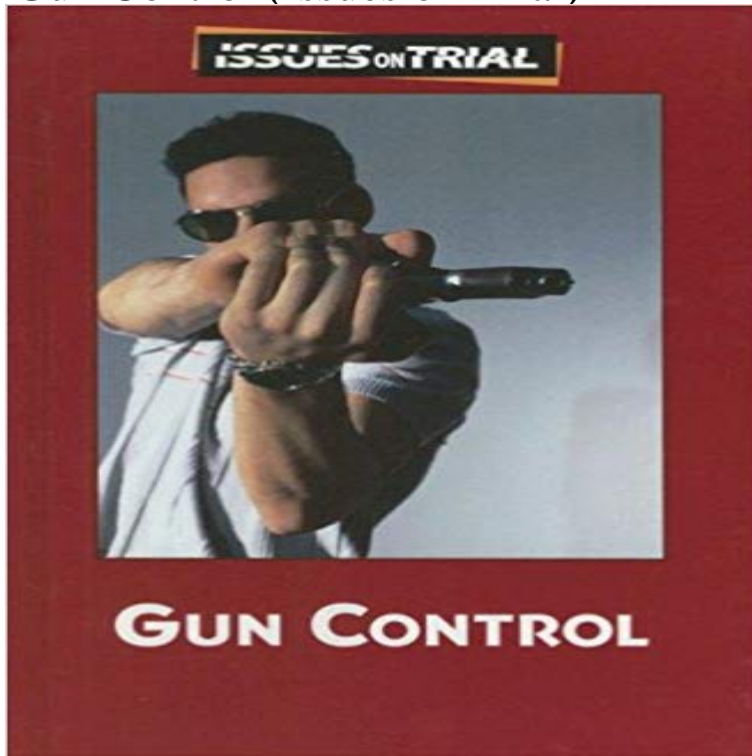


## Gun Control (Issues on Trial)
